

**Dear San Patricio County Teachers Federal Credit Union Member,**

Technology is changing the world. These days many credit union members no longer have a landline telephone, instead solely relying on a mobile phone as their primary means of contact. This change has complicated our ability to communicate with you because federal law has placed some restrictions on contacting consumers on their mobile phones.

The Telephone Consumer Protection Act generally requires businesses to obtain express consent before contacting members/customers on their mobile phones. To ensure that you don't miss any important communications, including possible fraud or suspicious activity on your account, we are requesting your permission to contact you on your mobile phone.

**By acknowledging and signing this consent form, you are granting permission to San Patricio Co Teachers FCU and any related affiliates or third-parties to contact you on the mobile phone number(s) listed below.**

You may choose to grant permission to contact you via phone call and text message, or phone call only (no texts). Consent is not required; you may opt-out of contacts to your cell phone number. Additionally, you retain the right to revoke permission at any time.

By consenting via this form, you grant permission to the credit union and related affiliates or third parties to contact you for any reason. Some examples of reasons we may contact you include: suspected fraud or suspicious activity, data security breaches, suspected identity theft, communications about existing accounts and loans, money transfers, notification of late payments, and/or collection efforts. **San Patricio Co Teachers FCU does not engage in telemarketing.** Please note that contacts may be made as a direct dial call or through the use of text messages, pre-recorded or artificial voice messages, and/or the use of an "automated telephone dialing system" or "autodialer".

By signing the form, you represent that you are the wireless subscriber or customary user with respect to the wireless number(s) provided and that you have the authority to provide consent. Please note that depending on your mobile service plan, message and data rates may be assessed by your mobile provider.

Should you choose to grant consent to contact your cell phone, you may withdraw consent or opt-out at any time by any reasonable means, including providing written notice to **San Patricio Co Teachers FCU 501 W.
