## **Important Notice to our Members:**

Changes to Funds Availability Policy Effective July 1, 2025

We've updating our funds availability policy in accordance with federal Regulation CC changes.

These updates reflect inflation-adjusted thresholds and will impact the amount of funds available for withdrawal from check deposits.

Minimum amount available from check deposits on the next business day: Increasing from \$225 to \$275

Large deposit threshold: Increasing from \$5,525 to \$6,725

No action is required on your part.
